### **WHY DO I NEED SECURITY AT MY EVENT ?**

- Almost all venues now require users to have certified and licensed security personnel on site during rental events, particularly events that have a large number of youth or young adults attending such as Bar/Bat Mitzvahs, Birthday parties and Graduation Parties.
- There has been an increase in the number of incidents of party crashers/uninvited persons who have been able to get into events undetected and caused fights, disorderly disruptions, and in some circumstances committed criminal offenses such as thefts of venue or guests' property, physical, sexual, verbal assaults and the like.
- There is a propensity for guests or intruders to illegally possess and consume alcoholic beverages.
- There is a propensity for guests or intruders to steal venue property or cause damage to the venue property (which by contract YOU as the leasing party on the contract are held financially and civilly responsible and liable to replace or reimburse).
- There is a propensity for guests or intruders to invade or be unsupervised in unauthorized spaces of the venue.
- There is a propensity for guests or intruders to act in an inappropriate, intoxicated or disorderly manner or to commit thefts from gift tables, guest purses, tables, or garments. These incidents must be immediately addressed, corrected and at times the person(s) committing the acts are asked to leave or they are actually escorted from the event and property of the venue. (In civil court judges have more frequently held that YOU the lease person responsible on the contract liable to replace or reimburse the guest(s) for any loss or damage).
- **DO NOT CONSIDER** using family, friends, or **UNLICENSED PERSONS AS SECURITY** for you event! They are not trained or authorized as security specialists and in the event of an unfortunate event they (AND MORE IMPORTANTLY YOU COULD BE HELD NEGLIGENT AND CIVILLY LIABLE FOR THEIR ACTIONS).

**REMEMBER ! YOU AS THE HOST AND OR CONTRACT LEASING PERSON ARE TOTALLY 100 % LIABLE FOR EVERYTHING THAT OCCURS AT THE EVENT, AND FOR THE SAFETY AND SECURITY OF THE VENUE, AND EVERY PERSON IN ATTENDANCE!**
